

## TERMS AND CONDITIONS

### Ocean Keys Shopping Centre: Ocean Keys Gifting Tree Promotion

#### **PROMOTIONAL PERIOD**

Promotion commences at 9:00am (AWST) on Saturday 24 November 2018, and closes at 9pm on Monday 24 December 2018, or when all prizes have been distributed, whichever comes first.

#### **HOW TO ENTER**

To participate in the Ocean Keys Shopping Centre 'Ocean Keys Gifting Tree' promotion, customers must follow the below steps during the Promotional Period:

1. Make a minimum spend of \$100 or more at any participating store within Ocean Keys Shopping Centre during the promotional period.
2. Present their receipt for \$100 or more to the Promotional Staff Member at the Ocean Keys Gifting Tree on the same day the purchase was made to confirm total purchase amount and the date on the receipt.
3. Customers are then eligible to select **ONE (1)** Mystery Present numbered 1 - 5 from underneath the Ocean Keys Gifting Tree. The Promotional Staff member will provide the customer with a token reflecting the number of the present they selected.
4. Customers must then present their token at the Information Desk to receive the corresponding mystery gift.
5. All customers who redeem a mystery gift from the Ocean Keys Gifting Tree will be required to provide personal details upon collection of their gift. If they refuse to provide all details, their present may be forfeited.
6. The Ocean keys Gifting Tree will be open for select hours each day for the duration of the promotion. If a customer visits the Ocean Keys Gifting Tree when it is closed, they may present their receipt to the promotional staff member at the Ocean Keys Gifting Tree the following day.
7. The winner of the major prize draw will be announced on Thursday 27 December at 9am.

#### **CONDITIONS OF ENTRY**

1. Information on how to enter and prizes form part of these conditions of entry. Entry into the promotion is deemed acceptance of these conditions of entry.
2. Entry is open to Australian residents aged 18 years or older. Employees of the Promoter and their immediate families and retailers within Ocean Keys Shopping Centre and the retailers' employees and their immediate families are eligible to enter, so long as retailers within Ocean Keys Shopping Centre and the retailers' employees and their immediate families are not using receipts from the stores they are employed with.
3. Customers may combine receipts from participating retailers at Ocean Keys Shopping Centre to total the required minimum spend of \$100, however purchases must be made on the same date.
4. Customers may enter up to **ONE (1)** times per day, but each entry requires the specified minimum spend of \$100 or more at any participating retailer within Ocean Keys Shopping Centre during the promotional period.
5. Customers will receive a maximum of **ONE (1)** mystery gift per minimum spend required

- and can receive a maximum of **ONE (1)** mystery gifts per day.
6. To select a present from underneath the Ocean Keys Gifting Tree customers must present their receipt on the same date the purchase was made. No presents will be issued after a date has passed on a receipt, excluding customers who visit the Ocean Keys Gifting Tee outside of the opening hours, who are then able to bring their receipt back the next day to select their present.
  7. The Promoter reserves the right to mark a receipt as used to redeem an mystery gift.
  8. The major prize is to be claimed no later than 5:30pm, Thursday 24 January 2019, unless otherwise stipulated, at the redemption point specified at Ocean Keys Shopping Centre.
  9. Receipts must be retained for proof of purchase in order to be eligible for the major prize draw.
  10. No responsibility is accepted for late, lost, or misdirected entries.
  11. Entries will not be accepted via mail.
  12. Entries that are illegible, forged, mutilated, copied or tampered with in any way will not be considered for prize redemption. If the Ocean Keys Shopping Centre staff have any reasonable doubt as to the legitimacy of the receipt/s being presented for entry, they obtain the right to refuse entry to said customer.

Receipts from partial lay-bys, gift voucher/card purchases, interest free purchase payments, eftpos and ATM receipts, bill payments such as the payment of credit card bills, bank transactions, bank fees and charges and service bills (such as gas, electricity, rates and phone bills), undated receipts, receipts dated outside the Promotional Period and receipts which have already been used to redeem a mystery gift cannot be presented as receipts to enter.
  15. Receipts from tobacco, fuel, lotto and TAB will not be accepted.
  16. Receipts from travel purchases over \$500, transaction receipts, medical service expenses, gift voucher purchases, tobacco purchases, lottery transactions, business purchases over \$500 and lay-by payments, except for the total amount (upon completion) are not accepted as part of the campaign.
